- 2) Applicant can reach the helpdesk Toll free number-1800-258-3878 and Helpdesk Email.





Figure 1. Single Window Portal Home Page




Figure 3. Registration Form




Figure 4. Registration Form Submission




Figure 6. Email ID Verification





Figure 7. Registration Confirmation Pop-Up

6. Combined Application Form (CAF)

- Prior to applying for various clearances on TNSWP, the applicant must create a project by filling in the combined application form (CAF).
- 2) Click on Combined Application Form (CAF) from the menu bar on the left.
- 3) The details which are commonly required for applying various clearances are stored in Central Repository through CAF. So, whenever the applicant applies for various clearances for a specific project, the details stored in CAF gets auto populated in the application form which minimizes the time spent on entering the same details while filling multiple applications.
- 4) The Overview of the Combined Application Form (CAF) and the instructions to fill in the Combined Application Form (CAF) are mentioned in the below Figure.




Figure 10. Combined Application Form (CAF)






Figure 13. List of Clearances




Figure 19. Under Process

8. Query Clarification




Figure 23. Status changed to 'inspection scheduled'


