In exercise of the powers conferred by sub-section(1) of section 85 of the Factories Act, 1948 (Central Act LXIII of 1948) and in supersession of Labour Department Notification No.II(2)/LAB/1172/87 dated the 4th February 1987 published at Page 133 of Part-II - Section 2 of the Tamil Nadu Government Gazette, dated the 25th February 1987 the Governor of Tamil Nadu hereby

declares that Sections 1, 2, 3, 5, 6, (Except 6(1)(a), (aa), (b) and (c)), 7, 8, 9, 10, 13, 21, 29, 31, 35, 38, 40, 45, 66, 67, 69, 70, 75, 76, 77, 78, 79, 80, 81, 82, 83, 85, 86, 87, 88, 88A, 89, 90, 91, 92, 94, 95, 98, 99, 101, 102, 104, 105, 106, 107, 109, 110, 112, 113, 117, and 118 of the said Act shall apply to the following establishments namely:-

1. Rice Mills;
2. Oil Mills.
3. Groundnut Decorticating factories;
4. Woodworking units, Using power in the manufacturing process;
5. Match works;
6. Fire Works;
7. Automobile Workshop, Using power in the manufacturing process;
8. Tyre Retreading;
9. Engineering Workshops;
10. Powerloom Factories;
11. Printing Presses, Using Power in the manufacturing process;
12. Hosiery Factories;
13. Factories using P. V. C.; and
14. Any manufactory in which ~~may~~ any of the operations declared to be dangerous under Section 87 of the Factories Act, 1948 (Central Act LXIII of 1948), is carried on using power in manufacturing process, other than those indicated above.
