




# 1. Home Page

- 5) The information icon (i) gives a brief description about the fields when the applicant hovers the cursor on these icons.






Figure 3. Registration Form





Figure 5. Mobile Number Verification








# 6. Combined Application Form (CAF)

- 1) Prior to applying for various clearances on TNSWP, the applicant has to create a project by filling in the combined application form (CAF).
- 2) Click on Combined Application Form (CAF) from the menu bar on the left.
- 3) The details which are commonly required for applying various clearances are stored in Central Repository through CAF. So, whenever the applicant applies for various clearances for a specific project, the details stored in CAF gets auto populated in the application form which minimizes the time spent on entering the same details while filling multiple applications.
- 4) The Overview of the Combined Application Form (CAF) and the instructions to fill in the Combined Application Form (CAF) are mentioned in the below Figure.
- 5) Click on 'Continue' button to fill in the Combined Application Form.


## **Figure 14. Search for Clearances**




# **10.** Query Clarification


## **11. Inspection Schedule**


