ORDER:

The Registrar General, High Court of Madras in his letter third read above has sent the following proposals to Government and requested orders thereon:-

- i. Constitution of one Commercial Court at Chennai (in the cadre of District Judge) instead of Designation of the Principal Judge, City Civil Court, Chennai as ordered in the G.O. second read above.
- ii. Constitution of six (6) Commercial Appellate Courts (in the cadre of District Judge) and Constitution of six (6) Commercial Courts (in the cadre of sub Judge) in cluster of the following Districts.

- 2. Therefore, he has requested the Government to sanction a sum of Rs.24,38,74,088/- (Rs.15,03,11,022/- Recurring Expenditure + Rs.9,35,63,066/- Non Recurring Expenditure) for constitution of the above Commercial/Appellate Courts and Mediation centres in the Courts along with 441 posts in various categories and other infrastructure facilities for use of the above courts and Mediation Centers.
- 3. The Government, after careful examination of the proposal of the Registrar General, High court, Madras, orders for the constitution of one Commercial Court at Chennai in the cadre of District Judge instead of Designation of the Principal Judge, City Civil Court, Chennai, Six Commercial Appellate Courts in the cadre of District Judge in cluster of Districts, Six Commercial Courts in the cadre of sub Judge in cluster of Districts as stated at para 1 above and creation of Mediation Centres in the above courts along with 234 posts in various categories and other infrastructure facilities for use of the above Commercial Courts/ Commercial Appellate Courts and Mediation Centres.

He is also requested to send necessary explanatory notes to the Government in Finance (Home-II/BG-I) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2020-2021 at the appropriate time without fail.
